Shiraz travel Ltd is registered and bonded by ATOL Civil Aviation Authority under the Air Travel Organisers Licence number 6689. Your contract with Shiraz Travel is governed by English laws and is subject to the jurisdiction of the English Courts and is deemed to have been made at Shiraz Travel's offices in London. Full payment(s) are to be made to Shiraz Travel by 25th Feb 2012. Various methods of payments are available e.g. Debit/Credit Card, bank transfer, cash or cheque. For cheque payments please allow 5 working days for cheque clearance. It is advisable that you purchase travel insurance to cover yourself sufficiently for the duration of the trip. If the deposit has been made but the full payment has not been received by end of agreed date the deposit will not be refunded and your place maybe offered to the next person in our waiting list. Shiraz Travel reserves the right to change its prices at any time before you book. If we do, you will be advised of the revised price applicable to your booking before you commit yourself. Thereafter the price of your travel arrangements is subject to surcharges on the following items for increases in: transportation costs e.g. fuel, scheduled air fares and other airline surcharges which are part of the contract between airlines (and their agents) and us, security charges, government action such as increases in VAT or any other government imposed increases, currency in relation to exchange rate variations. Alternatively you may choose to pay for your pilgrimage in full at the time of booking in which case Shiraz Travel will fix the price and the price will not be changed even if they go any higher than at the time you made the payment. We are not obliged to provide you with a breakdown of your pilgrimage cost since this would involve disclosing confidential financial information, which we are not prepared to provide.

Shiraz Travel is not liable to pay compensation where the change is by reason of unusual and unforeseeable circumstances beyond Shiraz Travel's control and which could not have been foreseen and avoided by the exercise of all due care. These includes, but are not limited to, war, threat of war, riot, civil strife, terrorist activity (actual or threatened), industrial dispute, technical problems with transport, machinery or equipment, power failure, natural or nuclear disaster, fire, epidemic, flood, drought, unavoidable technical problems with transport, and adverse weather conditions. No liability is accepted for delays to flights to or from the United Kingdom or for any cancellation and re-scheduling of flight departure times. We are also not liable to pay compensation where rail, road and other departure times are supplied by carriers since they are subject to traffic control, passenger check in times, weather conditions and the need for regular maintenance. You should consider making a claim under your travel insurance policy. If in our reasonable opinion or in the reasonable opinion of any representatives of airlines, hotels and/or tour leader your behaviour is causing danger, damage to property or persistently affecting the enjoyment of others, we reserve the right to terminate your pilgrimage. Should this happen, no refund or compensation would be paid. If your behaviour results in Shiraz Travel being forced to pay additional charges, Shiraz Travel will seek to recover the total amount with the addition of any legal expenses incurred as a direct result of your actions from you.
